

## Business License Fees and Required Information

In all incidences of a new business the name of the business must be recognized (legal recognition) by the County of Los Angeles or the State of California. This can be accomplished by either:

- Fictitious Business Name (filed with the County Recorders Office), or
  - Statement of Information (obtained from the State), when a business is incorporated (for profit or non-profit)
- When a Business is incorporated but is not using the name of incorporation  
a Fictitious Business Name must also be submitted

A \$1.00 CASp fee is included in each of the fees listed below.

Each business category in the list of items below is followed by items that are required to be received along with the Application unless the business is a new business as a result of a transfer of sale.
