League Play will begin: July 18, 2020

1. Eligibility:

- a. The age of a participant on August 22, 2020 will determine which age division he/she will participate.
- b. Age Classifications 8U, 10U, 12U, 14U, 17U (Some age groups may be combined based on registration numbers) There is a maximum limit of 20 players per league for Summer 2020.

2. Rules & Regulations:

- a. Governing Rules:
 - i. The local governing body for youth E-Sports programs is the City of Rosemead Parks and Recreation and the game rules of Madden 20.
- b. Games:
 - i. A regulation games will consist of four (4) quarters of six (6) minutes each.
 - ii. A game tied after regulation play will be played until completion based on the Madden 20.
 - iii. The score for a forfeited game shall be recorded as 7-0.
 - iv. The regular season will include nine (9) games. In a regular season, you will have one matchup a week followed by a single elimination tournament.

3. Special Provisions:

- a. Equipment:
 - i. Must have Play Station 4 or Xbox One and Controller.
 - ii. Madden 20 game for either PlayStation or Xbox One platform.
 - iii. PlayStation Plus Package or Xbox Live/Game pass membership (allows online multiplayer access).
 - iv. High speed internet access.
- b. Player Terms; Game Requirement, Game Settings, Player Conduct.
 - i. The home team stadium will be predetermined. The home team is the team listed on the right side of the game schedule. (Ex Patriots vs. Rams: Rams would be the home team).

- ii. In the regular season, you will have one matchup each week. The match up must be played during schedule day and time. Players are responsible for contacting each other to set up play (Contact Information will be provided by league coordinator).
- iii. After you have played your opponent, both players/parents will be responsible to report the results via email to jbobadilla@cityofrosemead.org with an attached screen shot of the final score.
- iv. It is the parent's and participant's responsibilities if there are any problems with lost connections during the game, participants must contact League Coordinator with in 10 minutes via email of the problem. League Coordinator will need to know the score, quarter, and what caused the game connection problem. Players will be asked to start the game over in the cases listed below.
 - 1. Power Outages.
 - 2. Internet Outages.
 - 3. Glitches out of player's control.
- v. If participants has continued connection problems while losing, they will get one warning, then expelled from the league. Any confirmed violation may result in immediate dismissal.
 - 1. 1st offense = Verbal warning.
 - 2. 2nd offense = Written warning.
 - 3. 3rd offense = Dismissal from the league.
- vi. Any player that quits or friendly quits will have to forfeit the game.
- vii. Participants are allowed to play against each other with the same teams (Ex: Both can play as the Dallas Cowboys)

- viii. Madden 20 game settings.
 - 1. Difficulty: Expert
 - 2. Game Length: Four (4)
 - 3. Quarter Length: Six (6) minutes
 - 4. Injuries: Off
 - 5. Teams: Current NFL teams only (No custom teams allowed)
 - 6. Weather: Clear skies
 - 7. Day or Night

4. League Standings

- a. League standings will be kept internally.
- b. Winning percentage is determined by wins/losses/ties.
 - i. Win = 1 point
 - ii. Loss = 0 point
- c. Tie Records
 - i. Best record.
 - ii. Head to head if there is a tie between two teams.
 - iii. If three or more teams are tied at the end, tiebreakers will be broken by:
 - 1. Best Record.
 - 2. Head to Head.
 - 3. Points Allowed.
 - 4. Points scored.
 - 5. Coin Flip.

5. Tournament

- a. League play will conclude with a single elimination tournament at the end of the season. Seeds will be based on league standings.
