

OVERVIEW

Chapter 5.04 of the Rosemead Municipal Code governs business license activity of the City. Per §5.04.10, the City adopted Title 7 of the Los Angeles County Code as its provisions regulating businesses in the City of Rosemead. As such, only businesses listed on the County's website and as defined in the Rosemead Municipal Code are required to obtain a business license for Rosemead. All other businesses having a physical address and/or conducting business within Rosemead but not required to obtain a business license, must participate in the City's annual business registration program. The business must be entered into one of the two classifications prior to commencement of any business activity and renewed annually until the business ceases operations.
